All male Jews between the ages of 17 to 45 were convicted as plunderers and to be executed by martial law. Up to 6,500 Polish Jews were executed along with up to 42,000 more were sent to Treblinka to be executed by gas chambers. The number of Jews waiting to be killed and the number of corpses could not be disposed of efficiently which led to corpses piling up. Jews were forced to lie in graves and wait to be shot while they must lie on the previous people who had been shot. Also, 59 transports of more than 53,000 Jews packed so tightly, that doors could barely close. Much of this book, was used and this is some of what has been learned.
